HAVE AGREED

ARTICLE 1 SUBJECT MATTER

1.1 This specific contract implements the Invitation to Tender issued by SAIDC on 5 April 2019 and awarded to the Contractor on 6 May 2019.

1.2 In accordance with the provisions set out in the Invitation to Tender (and the tendersubmission, dated 11 April 2019, in response) and in this specific contract and their annexes, which form an integral part of them, the contractor must provide the services specified in Annex 1.

ARTICLE 2 ENTRY INTO FORCE AND DURATION

- 2.1 This specific contract becomes binding on the date on which the last party signs it and enters into force on the day following its publication in the Central register of contracts maintained by Government Office of the Slovak Republic.
- 2.2 The provision of the services starts from 1 August 2019.
- 2.3 The provision of the services must not exceed six months from the date that the contract enters into force and becomes binding. The parties may extend the duration by written agreement before it elapses.

ARTICLE 3 PRICE

- 3.1 The price payable under this specific contract is EUR 20,515.00 (EUR Twenty thousand, five hundred and fifteen) excluding VAT.

The price is final and all costs related to the services are included. No other reimbursable expenses are foreseen and will be paid by the Contracting Authority.

Payment is due and payable in full on completion of the engagement, within 30 days after reception of the invoice by the Contractor, issued in EUR, in accordance with the contract. The report detailing the invoiced price, approved by the Contracting Authority will be enclosed to the invoice. There are no advance or interim payment instalments due.
