## Article II — Rights and Duties

1. This financial contribution covers and can be used solely for the provision of eligible goods and services related to the implementation of the “SlovakAid Fellowship Program for Change Leaders” during the period from the 18th of February 2021 to the 31<sup>st</sup> of January 2022. The program particularly covers and the contribution shall be used to finance the Fellowships for at least ten Change Leaders and to cover reasonable and necessary costs needed to implement the Project (including transportation costs, accommodation, visibility and related services, fellowships and mentoring costs, expert fees, management costs, rentals of premises, technical equipment and services, catering and board).

5. The Recipient is obliged to provide the final report on the implementation of the project to the SAIDC by the 31<sup>st</sup> of January 2022. The final report will consist of the narrative and financial report including the overview of the total costs incurred during the project implementation period, including supporting documents. It will also include photo and video documentation. The Recipient is obliged to provide additional documentation and sources of verification upon request from SAIDC or the Ministry of Foreign and European Affairs of the Slovak Republic.

All other terms and conditions of the Contract remain unchanged.

This Amendment I. become valid as of the day of its signing by both parties hereto, and effective as of the day following the day of its publication in the Central Register of Agreements administered by the Government Office of the Slovak Republic.
