5. The Recipient is obliged to provide a Completion report describing the implementation of the project, including photo documentation to the SAIDC by the **10th of May 2024**. The Recipient is obliged to provide additional documentation and proofs upon request of the SAIDC or the Ministry of Foreign and European Affairs of the Slovak Republic.

All other terms and conditions of the Contract remain unchanged.
